Kenya's Track record on CRC Implementation

Kenya ratified the United Nations Convention on the Rights of the Child (UNCRC) on 30th July 1990 and in a bold step domesticated the Convention by enacting the Children Act (Cap 586 Laws of Kenya). Kenya demonstrated commitment to the UNCRC by stipulating rights specific to children in Article 53 of Kenya 's Constitution (2010) and the subsequent enactment of several laws, including the Children Act 2022, to give effect to the Constitutional provisions.

Kenya is consistent in fulfilling its obligations as a State Party to the UNCRC. It has submitted its initial and several periodic reports on the level of implementation of the convention including its combined 6th and 7th periodic report. The reports have always conformed with the UNCRC reporting guidelines and are largely informed by the progress made in addressing the Concluding Observations of previous reports. Kenya is Cognizant that despite the progress made to safeguard the Rights and welfare of the child, there are challenges that still need to be addressed.

In this regard, Kenya is committed to forging partnerships and networks that will steer it closer to creating an environment that enables children to develop to their full potential.
